Called To Order

Chairman Hughes called the meeting to order and welcomed all present. He announced that Mark Crenshaw will be a voting member in the absence of Larry Felton.

November Minutes and Budget Work Session Minutes

A motion was made by Alissa Wilkerson, seconded by Rusty Slade, and unanimously carried to approve the minutes of the regular November meeting and the December Budget Work Session.

Review of November 2023 Financial Statement

Manager Hewitt reported energy sales for November were lower overall than November of last year. Revenue from sales were lower than the same month last year by 2.8%.

Hewitt reported sales were below the budgeted amount for the month in the Large Industrial Class but were slightly lower for all other customer classes. Total KWh sales is now 7.5% below the YTD budgeted amount. Weather for November was below the long-term average and the same time last year. There were 269 heating/cooling degree days for the month (3.9% below) compared to 280 in November 2022 and 2.7% below the long-term montly average of 277. River flows were below the period for last year and below the long-term average. Hydroelectric production was 28% less than the long-term average and 30.5% less than the same time last year. Unit #2 is currently still out of service for maintenance, waiting on shims to be delivered and Unit #3 is out of service due to broken gate links with approval from FERC on 10/18 to proceed with de-watering of unit for repair.

It was reported that cash available for operations as of November 30th was \$1,156,479 which is an increase of \$592,476 from the prior month. The available cash is lower than our recommended reserve level of \$7.9 million ~ \$9.5 million. Some large expenditures for ash remediation are expected for the remainder of the year and also into the next year. He reported although we are reaching the near end of the closure and are expecting those large expendictures, we will continue to watch and monitor the bank account as the revenues are remaining steady and the reerves are much lower. He recommended an approval to possibly transfer \$2M from the MCT before or by next month's meeting to bring available cash back up close to our recommended minimum, if needed, as a precautionary measure.

A motion was made by John Pridgen, seconded by Alissa Wilkerson, and unanimously carried to approve approved a \$2 million transfer from the MCT account, if necessary.

A motion was made by James Dowdy, seconded by John Pridgen, and unanimously carried to approve the November 2023 Financial Statements.

Transfer of Bad and Doubtful Debt List for 2022

Manager Hewitt reported the bad and doubtful debts for 2022 that need to be written off the books for audit reasons were \$67,610.38 which amounts to approximately 0.15% of revenue. He stated we are required to move these debts off our anticipated income at the end of 2022. Efforts will continue on collection of these accounts through various methods.

A motion was made by Rusty Slade, seconded by Alissa Wilkerson, and carried to approve the transfer of the Bad and Doubtful accounts.

Report on ECG Election

The Electric Cities of Georgia held its board election at their annual meeting earlier this month. Hewitt reported Jay Bartlee from the City of LaGrance, Craig Mims from the City of Forsyth, and Blake Manning from Crisp County Power Commission were elected to 3-years term.

Proposed Budget 2024

Manager Hewitt stated there had been no significant changes to the 2024 budget from the proposal that was presented at the Budget Work Session except the updated projections using November data and Staff recommendation was to adopt the Budget which had been discussed. His recommendation was to increase rates uniformly by 4%.

A motion was made by John Pridgen, seconded by Alissa Wilkerson, and unanimously carried to approve the 2024 Budget.

Current Projects

- Becky Fitzgibbons reported the annual warehouse audit will take place on Wednesday, January 10, 2024.
- Ronnie Miller reported shims have been ordered and should arrive early-mid January. He also reported the contractor that is working on Unit #3 stated they hope to be completed by January 16, 2024.
- Rick Vaughn reported there were 31 total outages that affected 936 customers. He
 reported he continues to work on the modeling loads fo the ADS future expansion.
- Clint Branch reported they continue work at Pateville sub. He reported there are several irrigation projects. Crews continue to work at the old Middle Schoo and at the SGTC parking lot.
- Chad Young reported he continues to work on the communications to the automatic reclosers.
- Blake Manning reported crews continue to work at Pateville Sub and on daily work.
- Troy Gilliam reported things are slow around the Lake other than some minor dock repairs. He reported we received our 1st \$250 permit.

Other Business

Manager Hewitt presented Commissioner Warren Ray Hughes with an Arcman Lamp for his years of service as a Grand Jury Appointed Commission.

Hewitt reported a need to go into Executive Session to discuss personnel.

A motion was made by Sam Farrow, seconded by Rusty Slade, and unanimously carried to go into Executive Session to discuss personnel.

At the conclusion of the Executive Session the Commission reconvened in regular session.

The Chairman called the meeting of the Crisp County Power Commission back into regular order.
